# Spring Fling

## Art in the Garden Festival

*Spring Fling is a juried arts & garden festival*

### **Festival Dates:**

Saturday – Sunday May 5-6, 2012, 10AM -5PM

Artist Market, Garden Plants and Accessories, and Entertainment featured throughout the weekend.

### **Entry Rules and Regulations:**

- **Entries must be postmarked by April 21, 2012**
- Artists (new) must send jpegs of four pictures (three of artwork/one of booth).
- All work on display must be of the artist's original design and made specifically by the registering artist.
- Artists must be present to display work. No commercial agents, dealers, or salespeople are allowed to tend artwork.
- Artists are responsible for their own display booth. All tents must be 10' x 10' canopy tents: no stake down, weights ONLY. Please be prepared for inclement weather.
- Artists are responsible for collecting and reporting all sales tax.
- Plant vendors will have water access.
- Indoor spaces are available on a first-come basis.
- Photo I.D. is required.

### **Fees**

- Please make checks payable to: DCAC - Spring Fling.
- \$20 Non-refundable jury fee deposit upon submittal of entry form. Last year's vendors need not send jury fee as they are automatically accepted for the 2012 festival.
- \$100 (\$150 indoor) Booth Fee due at the time of entry plus an additional \$25 fee for electrical hook-up (by separate check), deposited at time of acceptance. Limited Food Booth (3 or less foods) \$100.00. Premium Food Booth (more than 3 foods) \$250.00.
- **\$75.00 late fee after April 21, 2012.**
